The price of the trip includes: transportation, equipment rental, lodging, one (1) lesson, lift tickets, and eight (8) meals

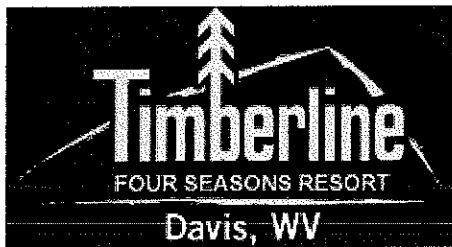

****SPENDING MONEY****

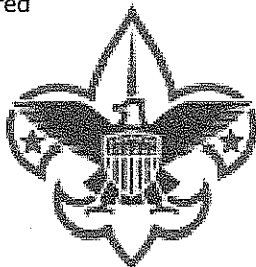
You will need to bring spending money to purchase three meals (travel to and from) and what ever souvenirs you wish to buy.
